

Dear Members,

We are pleased to inform you that CA Association, Ahmedabad has organized an International RRC (Residential Refresher Course ) in Thailand (3 nights - **Phuket**, 2 nights - **Krabi** & 2 nights - **Bangkok**) From 5th January, 2017 to 13th January, 2017 i.e. 7 nights and 8 days . Members can join the RRC with their spouse and children. The detailed tentative itinerary is enclosed herewith which is self explanatory. The approximate tour cost is as under.

Member	:	Rs. 70,800/- per person
Member's spouse	:	Rs. 70,800/- per person
Child below 11 years with bed	:	Rs. 61,800/- per person
Child without Bed	:	Rs. 49,800/- per person

The above cost includes airfare to and fro Thailand - Ahmedabad, Accommodation, All meals, Sight seeing as per the itinerary, Course material, and Insurance etc. (Visa fees is not included which is approx Rs. 2200/- to be paid to travel agent ( As per information Thai Government has proposed to revise Visa fees - difference if any will have to be paid separately).

**Total number of seats are limited to Forty only and will be available on first come first serve basis.**

Interested members can register for the RRC by filling and submitting the enclosed form with a Cheque of Rs. **35,000/-** per person drawn in favour of TravelSukha along with duly filled registration form. The advance of Rs. **35,000/-** is strictly non refundable in case the member opts for not joining the RRC for any reason. **The balance amount shall be payable on or before 30th November, 2016. Please note that valid passport with atleast six month's expiry before the date of travel is required.**
